I agree to indemnify and hold IMG, its affiliated companies, successors, licensees and assigns, harmless from and against any and all claims, damages, liabilities, costs and expenses arising out of any breach of the foregoing warranties. I acknowledge that IMG will rely on this permission potentially at substantial cost to IMG, and hereby agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder and waive any right to seek an injunction or other equitable relief or otherwise to prevent the full exploitation of the CSOI Website and all rights granted herein.

If any controversy or claim arising out of or relating to this Still Photograph Release or the breach of any term hereof cannot be settled through direct discussions, the dispute shall be referred to arbitration by a member in good standing of the Law Society of Upper Canada as mutually agreed to by the parties. If they fail to agree to such an arbitrator, an application may be brought by either party to the Ontario Court (General Division) for the appointment of an arbitrator. Any arbitrator so appointed shall proceed to determine the rights and obligations of the parties pursuant to the provisions of the Arbitrations Act (Ontario) and the arbitrator's decision shall be final and binding on the parties hereto.
